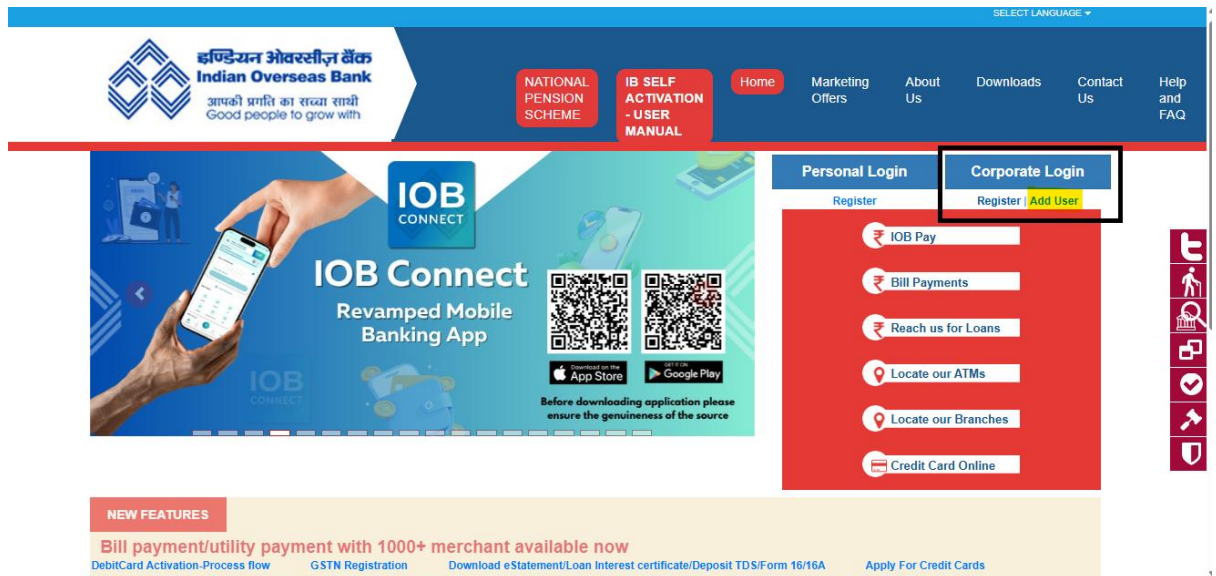

 - **Password:** User to create a Password of his/her own choice, of 8-15 characters containing alphabets (both uppercase and lowercase), numbers and special characters.
 - **Residential Status:** User to select residential status from the dropdown (Resident Indian/Non-Residential)
 - **Country:** User to select country from the dropdown
